THE SECOND PPP LOAN INCLUDES THE SAME GENERAL TERMS AS THE FIRST PPP LOAN REGARDING FORGIVENESS AS LONG AS THE PROCEEDS ARE USED FOR QUALIFYING PURPOSES AND CERTAIN CONDITIONS ARE MET.
